1. UNE-EN ISO 14001 Certification

We are certified under the **UNE-EN ISO 14001** standard, the global benchmark that validates the effective implementation of our Environmental Management System.

This certification reinforces our legal compliance, resource management optimization, and continuous effort to prevent and minimize any environmental impact arising from our activities.

2. Carbon Footprint and Measurement Accuracy

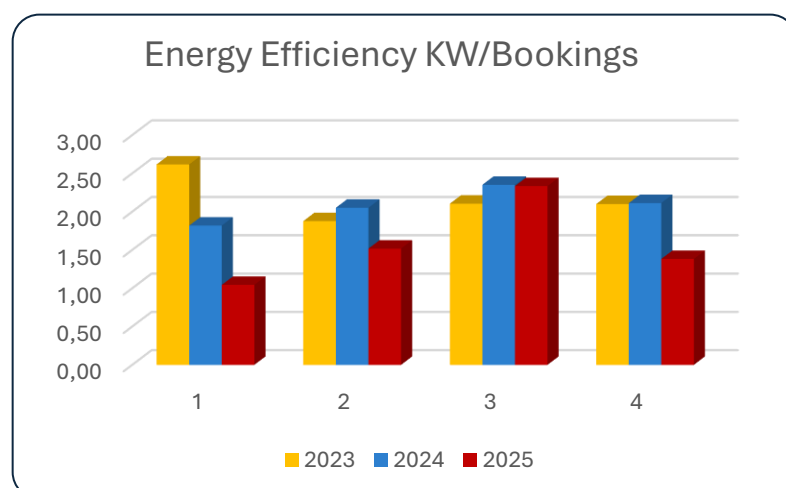
We annually calculate the direct emissions generated by our commercial fleet and the electricity consumption of our offices under **Scopes 1 and 2**.

Regarding indirect emissions (**Scope 3**), we calculate Scope 3 emissions for all customers who request them, following the **GLEC Framework**, the leading global standard for logistics emissions accounting.

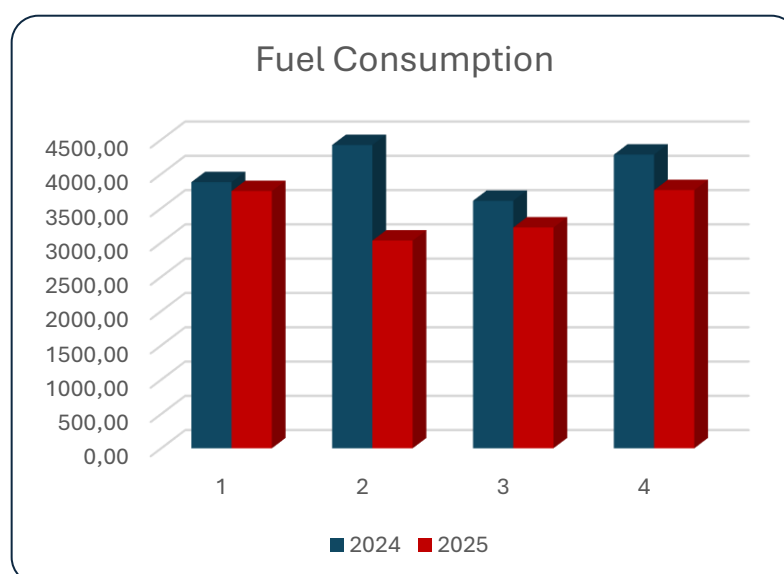
3. Consumption Trend

Since 2023, we have maintained strict control and continuous monitoring of our internal consumption, achieving effective reductions through the optimization of every resource:

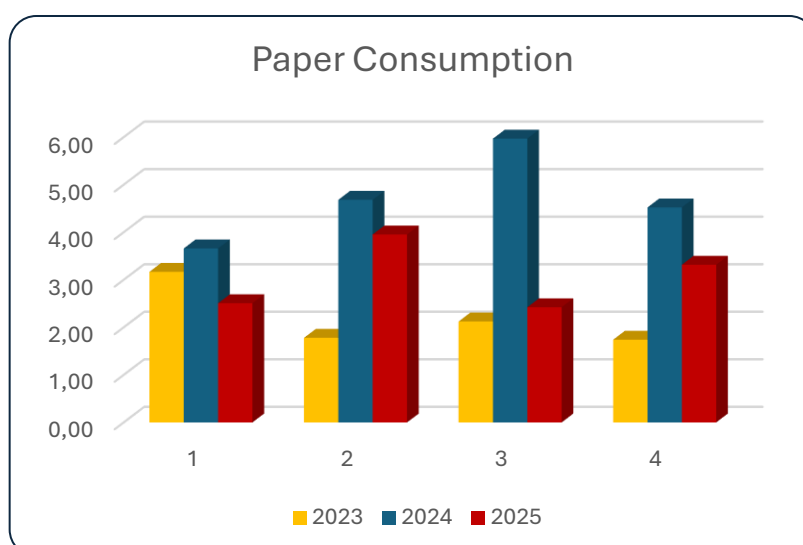
Energy Efficiency: We assess our electricity consumption through the key indicator of kWh per operation, directly linking energy use to business activity.



Fuel Consumption: We monitor the liters of fuel consumed by our commercial vehicles.



Paper Consumption: We actively measure paper consumption across our branches, promoting complete digitalization.

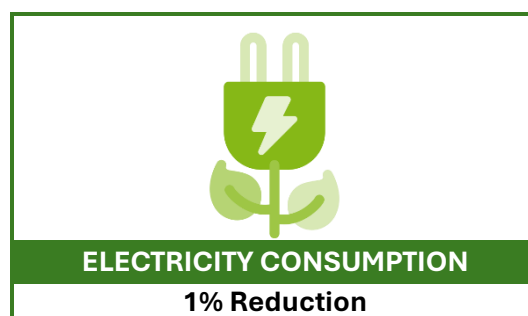


4. Environmental Objectives for 2026

For 2026, our company is firmly committed to raising its management standards and further reducing its direct operational impact through clear objectives.

Building on our strong experience with ISO 14001, our primary objective this year is to become integrated under **TIBA SPAIN's UNE-EN ISO 14001 certification**. This key step will allow us to unify criteria and align our environmental policies with the group's global guidelines.

In addition, **TOTAL TIBA AIRFREIGHT S.L.** remains strongly committed to reducing its direct operational impact. To achieve this, we have established the following quantitative targets for our key consumption indicators:



To achieve these goals and mitigate the overall impact of our activities, we will prioritize the following action:

- **Active Awareness:** We will continue providing training focused on environmental awareness, promoting clean transportation methods, and sharing daily sustainability best practices within our offices.
- **Digital Transformation:** We will continue advancing the digitalization and standardization of operational processes, strongly promoting the use of electronic signatures to eliminate paper consumption.
- **Carbon Footprint Compensation Actions (Group Level):**
 - **Continuous Innovation:** Redesigning and evolving our business models to make them structurally more sustainable.
 - **Efficient Routes:** Proactively evaluating transport routes and providing customers with detailed environmental impact information, always offering lower-carbon logistics alternatives whenever possible.
 - **ESG Culture and Circularity:** Formal and systematic integration of circular economy practices and ESG (Environmental, Social, and Governance) criteria into our daily operations.
